## EMPLOYMENT SERVICES

A program designed to assist you by matching new or existing jobs in your business with eligible candidates. You, as an employer, may receive a financial incentive to train these candidates.

A \$2000 Apprenticeship Employer Signing bonus (AESB) is available to employers who hire, register, and train an apprentice as part of their participation in a job placement.



## YOUTH JOB Connection

Employers can access eligible candidates who are interested in learning more about working in their industry. Youth aged 18 to 29 will have completed 60 hours of pre-employment workshops prior to starting a placement with an employer. Youth will be provided with any training supports that the employer requires for the position. Employers may be eligible to receive up to \$6000 towards placement incentives.



# YOUTH JOB Connection-summer

YJCS (Youth Job Connection -Summer) is a new program that assists youth aged 15 to 18. The program aims to develop job readiness skills and boost confidence. This program provides them with pre-employment training and work opportunities that will help them make positive educational and career choices.

### EMPLOYER PLACEMENT ELIGIBILITY

- Be licensed to operate in Ontario
- Comply with all applicable legislation, including federal and provincial human rights legislation, regulations, and any other relevant standards, Occupational Health and Safety Act and the Employment Standards Act, freedom of information and protection of privacy legislation
- Provide the placement in Ontario
- Maintain appropriate WSIB or alternative workplace safety insurance coverage and have adequate third party general liability insurance as advised by your insurance broker
- NOT hire his or her immediate family members, such as parent, spouse, sibling, or child as a trainee
- NOT be receiving government funds from any other source for the same training placement
- NOT use placement services to replace existing or laid-off employees

#### **OTHER PLACEMENT COMMITMENTS**

- Develop a relevant training/work experience plan that will help the trainee achieve their labour market/employment goal and help the employer develop their business goals
- Provide feedback and assessments of the trainee's skill level and having a potential long-term employment/contract position for the trainee
- Demonstrate the ability to provide the trainee with adequate supervision and training as described in the training plan
- Place trainees on the company's payroll and provide the same employment in terms, conditions, and benefits as for all regular employees
